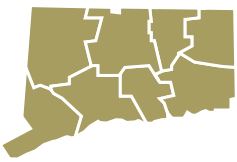

UConn's research operations make real and vital contributions to the state's economy. Research dollars are out-of-state money entering the Connecticut economy through UConn, but the impact doesn't end there. The University is actively engaged in promoting entrepreneurship and commercial ventures as part of its mission, and as research expenditures continue to grow, that impact will only become greater.

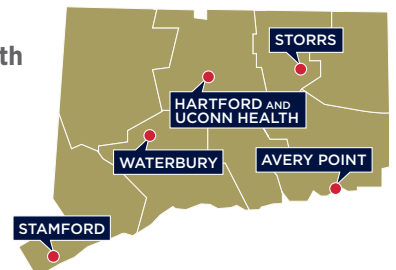
